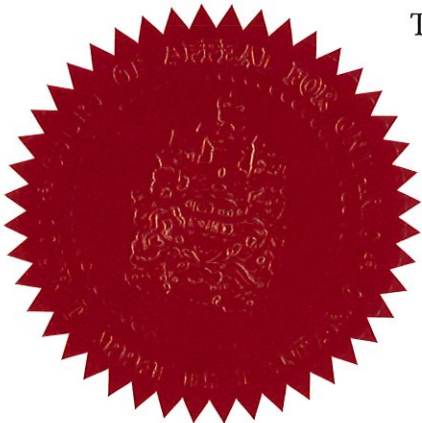

**ORDER**

THIS COURT ORDERS that:

1. Animal Justice Canada is granted leave to intervene in the within appeal and cross-appeal;
2. Animal Justice Canada shall be entitled to serve and file a factum not to exceed twenty (20) pages in length, addressing both the appeal and the cross-appeal, by June 19, 2019;

- 3. Animal Justice Canada shall not seek costs against any other party, nor shall any party seek costs against it;
- 4. Animal Justice Canada shall not expand the record in the appeal and cross-appeal, including by adding materials that would appropriately be the subject of a motion for fresh evidence;
- 5. The appellant in the appeal will serve and file any material responding to the cross-appeal and to Animal Justice Canada, and the respondent in the appeal will serve and file any material responding to Animal Justice Canada, by July 19, 2019; and
- 6. Animal Justice Canada shall be entitled to make up to forty (40) minutes of oral submissions at the hearing of the appeal and cross-appeal, subject to the discretion of the panel hearing the appeal and cross-appeal.
